This is regarding examining the proposed modifications of the Recruitment Rules for Non Faculty posts of AIIMS Patna in accordance with the approved Minutes of the 2<sup>nd</sup> Meeting of the IB of AIIMS Patna.

The matter has been carefully examined in the Ministry and the approval of President of the Institute has been obtained on the modifications and the same are detailed below:
