ADVERTISEMENT FOR FILLING UP THE FOLLOWING POSTS OF:

- (I) SUPERINTENDING ENGINEER
(II) EXECUTIVE ENGINEER (CIVIL)
(III) EXECUTIVE ENGINEER (ELECTRICAL)
ON TRANSFER ON DEPUTATION BASIS IN THE ALL INDIA INSTITUTE OF MEDICAL SCIENCES (AIIMS), RAE BARELI ESTABLISHED UNDER PRADHAN MANTRI SWASTHYA SURAKSHA YOJANA (PMSSY).

I. The Ministry of Health & Family Welfare, Government of India has set up AIIMS like institute at Rae Bareli besides AIIMS like institute at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh under Pradhan Mantri Swasthya Suraksha Yojana as Institutes of National Importance. Application from eligible candidates are invited in the prescribed proforma for appointment on deputation basis for the following posts:

(a) **Superintending Engineer** at AIIMS Rae Bareli in the PB-4 Rs.37400-67000 with Grade Pay of Rs.8700/-

(a) **Executive Engineer (Civil)** at AIIMS Rae Bareli in the PB-3, Rs.15600-39100 with Grade Pay of Rs.6600/-

(b) **Executive Engineer (Electrical)** at AIIMS Rae Bareli in the PB-3 Rs.15600-39100 with Grade Pay of Rs.6600/-

II. The post of **Superintending Engineer and Executive Engineer (Electrical)** will be operated at MoHFW, New Delhi and the post of **Executive Engineer (Civil)** will be operated at project site i.e. AIIMS Rae Bareli.

III. Duly filled application along with attested copies of all relevant certificates are to be sent by the applicant to **Sh. Vinod Kumar, Under Secretary (PMSSY), Room No. 103-D Wing, Ministry of Health & Family Welfare, Nirman Bhawan, New Delhi-110108** superscribing on the envelope "Application for the post of Superintending Engineer/Executive Engineer (Civil)/Executive Engineer (Electrical)". **The closing date for receipt of application is 30 days from the date of publication of the Advertisement in the Employment News.**

IV. The initial period of deputation shall ordinarily be three years from date of appointment, further extendable as per Govt. of India rules. Pay will be protected as per Government of India rules.

V. **Upper age limit:** The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.

VI. **Eligibility:-**
Superintending Engineer -
Officers under the Central Government/State Government/Statutory/ Autonomous Bodies Engineering Departments, possessing the following educational qualifications and experience:-

- (i) Degree in Civil Engineering from a recognized University or equivalent;
(ii) Holding analogous posts on regular basis or
(iii) Executive Engineer (Civil) with 5 years of regular service in the grade from CPWD/similar officers from other Central/State Engineering Departments or Engineering Departments of Central/State Statutory/Autonomous Bodies and possessing 5 years regular service in the grade.

Executive Engineer (Civil) -
Officers under the Central Government / State Government/ Statutory/ Autonomous Bodies Engineering Departments, possessing the following educational qualifications and experience:-

- (i) Degree in Civil Engineering from a recognized University or equivalent;
(ii) Holding analogous posts on regular basis or
(iii) Assistant Engineer (Civil) with 8 years of regular service in the grade from CPWD/ similar officers from other Central/State Engineering departments or Civil Engineering Departments of Central/State Statutory/Autonomous Bodies and possessing 8 years regular service in the grade.

Executive Engineer (Electrical)
Officers under the Central Government / State Government/ Statutory/ Autonomous Bodies Engineering Departments, possessing the following educational qualifications and experience:-

- (i) Degree in Electrical Engineering from a recognized University or equivalent; (ii) Holding analogous posts on regular basis Or
(iii) Assistant Engineer (Electrical) with 8 years of regular service in the grade from CPWD/ similar officers from other Central/State Engineering Departments or Electrical Engineering Departments of Central/State Statutory/ Autonomous Bodies and possessing 8 years regular service in the grade.

VII. The post carries usual allowances as admissible to Central Government Employees of similar status and other allowances sanctioned in AIIMS New Delhi.

VIII. The qualification/eligibility prescribed is minimum requirement and the same does not automatically make candidates eligible for selection. Based on bio-data, the Selection Committee will short-list candidates who may be called for interview. The candidates have to produce all relevant original documents in proof of details furnished in their application at the time of interview.

IX. Interviews for selection to the post will be held at New Delhi. No TA/DA will be paid to candidates called for appearing in interview by the Ministry of Health & Family Welfare.
