Note: i) M/o Health & Family Welfare may ensure that Pay Level/Nomenclature of posts agreed for creation is at par with Pay Level/Nomenclature of posts existent in AIIMS, New Delhi and that all posts are filled up on regular basis as per approved Recruitment Rules only.

2. The above creation is agreed subject to the following conditions:

i) AS & FA may certify that Pay Level/Nomenclature of posts agreed for creation by Department of Expenditure is at par with Pay Level/Nomenclature of similar posts existent in AIIMS, New Delhi before initiating recruitment to the posts.

ii) The anomaly that has been created in Pay Level/Nomenclature of some posts in new AIIMS vis-a-vis AIIMS, New Delhi needs to be corrected. A possible solution to address this anomaly is to re-designate the posts created at a higher level as promotional posts (at par with Pay Level/Nomenclature of promotional posts in AIIMS, New Delhi) while fresh recruitments in the new AIIMS can be carried out at lower level at par with AIIMS, New Delhi. This scheme may be formulated and also informed to this Department.

iii) M/o Health & Family Welfare may ensure that at least 75% of posts in each grade/cadre are filled up before seeking further creation of posts in various new AIIMS.
