
Subject: Request for Comments on "Draft Guidelines for implementation of PMSSY Scheme"

Sir / Madam,

As you are aware, the Ministry of Health and Family Welfare, Government of India is implementing Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), a Central Sector Scheme, which was announced in August 2003 to address imbalances in availability of tertiary care hospitals and improve medical education in the country. The Scheme has two components:

- a. **Setting up of new AIIMS:** Out of total twenty-two new AIIMS announced so far, six AIIMS are functional and another fifteen AIIMS have been approved.
 - b. **Up-gradation of existing State/Central Government Medical College/Institutions (GMC):** This involves construction of Super Speciality Block/Trauma Centre and procurement of Medical Equipment and as on date seventy-five projects in twenty-three states has been approved.
2. Based on experience acquired in course of implementation of the scheme, the Ministry has formulated a **"Draft Guidelines for Implementation of PMSSY Scheme"** to create a uniform, systematic and streamlined approach; which is being circulated herewith to obtain valuable comments of all stakeholders. It is requested that comments on the same may kindly be provided by 5th of February, 2020 so as analyse, evaluate and suitably incorporate within the Draft Guidelines to achieve a more cohesive and collective policy in this regard.

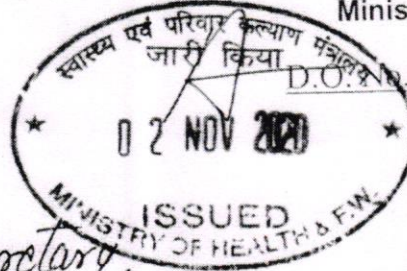

Dear Chief Secretary,

As you are aware, the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) Scheme is being implemented with the objective of correcting regional imbalances in availability of Tertiary Care Facilities and to improve Medical Education in the country. Under the Scheme new AIIMS are established and also upgradation of existing Government Medical College/Institutions (GMCs) is taken up by way of construction of Super Speciality Block/Trauma Centre and procurement of Medical Equipments. 22 new AIIMS and 75 GMC up gradation projects have been taken up so far.

2. Based on experience acquired in the process of implementation of the scheme, the Ministry has formulated a draft document on "**Guidelines for Implementation of PMSSY Scheme**" to create a uniform, systematic and streamlined approach. In this regard this Ministry vide letter dated 17th January, 2020 (copy enclosed) requested all the stakeholders to provide their valuable comments/feedback on the proposed Guidelines. So far comments have been received only from Bihar, MP, Odisha and Sikkim. Comments from all remaining States are still awaited.

3 I may request you to look into the matter and direct the concerned officers to provide the comments of the State within a fortnight so as to enable the Ministry to finalize the Scheme Guidelines without further delay.
