## MINUTES OF THE MEETING OF THE APEX COMMITTEE ON PROCUREMENT OF CSSD, MGPS AND MOT FOR SIX NEW AIIMS, HELD UNDER THE CHAIRMANSHIP OF SECRETARY (HFW) AT NIRMAN BHAVAN ON 19th AUGUST 2014.

- 1. A meeting of the Committee constituted vide MoHFW Order No. Z-28016 / 2/ 2012-SSH Dtd. 31-Jan-2013 was held under the Chairmanship of Secretary, HFW on 19 August 2014 at PM in the Committee Room of Secretary HFW located in A-Wing, Nirman Bhavan, New Delhi. M/S HLL Lifecare Ltd, the Procurement Support Agent (PSA) had circulated detailed agenda note well in advance. The meeting considered the pre-bid related issues/ recommendations of the 23-Member Inter-Institution- Technical-Experts' Committee regarding amendments to Tender No. AllMS / II / 13, 14 and 15.

- 3. Secretary, HFW welcomed the participants and requested JS (PMSSY) to give a brief background of the meeting. JS (PMSSY) talked about the background of setting up of the Committee as per written orders (issued in January 2013) of then HFM and stated that then HFM had noted the fact that several Directors of the new AIIMS had, on their own and as per their convenience and choice, placed advertisements in the newspapers asking for supply, installation, testing, commissioning etc. of equipments such as modular OTs, intelligent OTs, medical gas pipeline system, manifold, kitchen/laundry/CSSD equipments without any approval. Then HFM had asked Secretary, DHFW to constitute a Committee of experts under his Chairmanship so that no unauthorized activities in the matters of procurement and recruitment took place. Several meetings of the Committee had taken place and minutes stood issued. The PSA was supposed to abide by the directions and guidelines of Government, GFRs and also CVC guidelines, JS (PMSSY) stated. He also stated that PSA had to truthfully submit all documents in proper form to any investigating agency which might ask for the same as per procedures. JS (PMSSY) asked the PSA to make detailed presentation.
- 4. PSA briefed the Committee about the status of procurement of MOT, MGPS and CSSD for six AIIMS. It was submitted that Apex Committee was formed in January 2013 under the chairmanship of Secretary HFW to finalize procurement of CSSD, MGPS, MOT, Laundry etc. This was done with directions of HFM in the backdrop of certain AIIMS calling for EOI/RFP at individual level for this procurement. Apex committee formed subcommittees to assist the Apex committee. The subcommittee headed by one of the new AIIMS Director submitted technical specifications and tender document for consideration and approval of Apex committee. After appointment of PSA they submitted certain suggestions. An industry meet was held where users, PSA

and industry specific to CSSD, MGPS and MOT participated. With the inputs of industry, PSA resubmitted draft of specifications and tender document including commercial conditions and qualification criteria. A 23-member committee was constituted with the approval of Secretary HFW to finalize technical specification and qualification criteria and tender conditions. The 23- member Committee after its meeting in December 2013 submitted its recommendations which were placed before Apex Committee in January 2014. After the approval of technical specifications, qualification criteria and tender conditions, PSA floated the tender for the three services (CSSD, MGPS and MOT) in the month of March 2014. The pre-bid meetings for all the three tenders were held on 3 different days that is, on 10, 11 and 12 March 2014 at PSA office in presence of pre-bid committee wherein many likely bidders gave representations. The pre-bid meetings of MGPS and MOT were also video recorded. On demand from CVO MoHFW and from CBI, probably due to the representations from the likely bidders reaching them, copies of tender documents had been submitted to CVO/ CBI by PSA. It was briefed that the pre-bid representations, at first stage were disposed off by the pre-bid committee (technical and commercial) as per MoHFW Order dated 5 July 2013. Thereafter, representations by likely bidders and other representations along with recommendations of pre-bid committee were put up to the 23-member committee constituted vide MoHFW order dated 18th December 2013 for giving recommendations. This committee met for the second time on 30 June and 1 July 2014 at Nirman Bhawan and submitted their recommendations. The Apex Committee meeting was called to deliberate, consider and decide on the recommendations of the 23member committee. The three tier recommendation/approval system was designed keeping in mind the sensitivity and volume of procurement. Thereafter, Shri RS Manku (PSA) gave point wise presentation of the proposed changes recommended by the 23-member committee.

- 5. Shri R.S. Manku, Head PCD, HLL (PSA) said that entire exercise was divided into two parts. The first part was regarding representation/changes requested by the likely bidders in commercial terms and conditions/ qualification criteria and the second part was regarding representation/changes requested by the likely bidders in technical specifications/ BoQ in respect of above referred tenders (CSSD, MGPS, MOT), amendments recommended by the pre bid approval committee (technical and commercial, MoHFW order dated 5 July 2013, para B3 and B4) and the recommendations of 23 member committee in their meeting held on 30 June and 1 July 2014 at Nirman Bhawan, New Delhi..
- **6.** After detailed discussion and deliberation, in the light of presentation and recommendations of PSA, the decisions are recorded in a tabular manner as follows:

- 7. Regarding increase in estimated cost as presented by PSA, it was decided that budget for CSSD, MOT and MGPS would remain the same i.e. Rs 248 cr as already approved. If the actual cost increased, the number of MOTs would be reduced.
- 8. Regarding changes in technical specifications/BOQ it was decided in the light of recommendations of PSA, that changes as proposed by 23 member committee were acceptable. It was decided that PSA, after incorporation of changes in technical specifications/BOQ as recommended by 23 member committee and accepted by Apex committee, changes in qualification criteria and commercial conditions as approved by apex committee, incorporations of new conditions and details as decided by Apex committee, incorporation of clear scope of 40% work, least cost method, should get the entire bid document for CSSD, MGPS and MOT signed from 23 member committee for placing before apex committee for approval.
- 9. The Committee noted that PSA had stated that all original documentation related to work as PSA for six new AllMS including proceedings of various meetings were being maintained by PSA and kept in the custody of PSA, in proper manner and also as per applicable guidelines.

The meeting ended with a vote of thanks to the chair.
