The Member-Secretary informed that the minutes of the $\mathbf{1}^{\mathsf{st}}$ meeting of the GB were only received on 26th March, 2016 from the MoH&FW after signature by the Hon'ble Chairman, Governing Body. As the agenda for the 2nd meeting of the GB for 31st March, 2016 was already circulated, the Action Taken Report of the last GB could not be enclosed with the agenda due to paucity of time. However, the Member-Secretary informed some of the action taken report with the permission from Chair which are publication of result of the five phases of the selection of faculties and issuing of offer of appointments to 86 selected faculties as approved by the GB in its 1st meeting held on 18th January, 2016 under agenda No. GB-01/11 in addition to the publication of the result of the selection process of the post of "Medical Physicist (Group-A-Non-Faculty) as approved by the GB under agenda item No. GB-01/12. The Institute had also requested AIIMS, New Delhi to advertise the PG seats as approved by the GB in its first meeting under agenda No.GB-01/07, in response to the said request, AIIMS, New Delhi vide their letter dated 20.02.16 has asked to get the proposal approved by the MoH&FW regarding inclusion of PG seats under PG entrance examination (July-2016) conducted by them. AIIMS, Bhubaneswar has sought approval from MoH&FW vide letter No. AIIMS/BBS/Dir/PG, dated 30th March, 2016 to include the PG seats under the entrance examination conducted by AIIMS, New Delhi and the approval from the MoH&FW is awaited. The GB Has also approved that students for the above courses will be selected on merit on all-India basis and each students enrolled for these courses will be paid Rs.3,000/ stipend per month. All the students have to work for a period of 2 years at AIIMS, Bhubaneswar after the completion of the courses on payment of Rs.15, 000/ consolidated stipend per month, they have to pay Rs. 2 lakh in lieu of 2 years of mandatory service period (in case of leaving on the middle, proportion amount of Rs.2 lakh vis-à-vis 24 months is to be paid). The Courses curriculum will be as per AIIMS, New Delhi/Other Central Institute course curriculum. While approving this agenda, the GB has asked to start the courses from July-2016 to meet the urgent need of trained technicians, but the Member-Secretary has informed that the start of the courses from July-2016 may not be possible as advertisement is to be published and written test is also to be conducted which will take some more time. Accordingly, GB has instructed to take immediate steps for starting these courses at the earliest.

Agenda Item: GB- 02/11

Information regarding release of RA Bills, RA Bills to contractors and Project Fund to M/S HSCC etc. consequent upon transfer of payment activities at the new six AIIMS site.

While presenting this agenda, Member-Secretary has stated that the Director of the AIIMS, Bhubaneswar has been delegated power up to Rs.2 crore to incur expenditure on procurement of Institute equipment vide Circular No. Z-28016/37/2014-SSH, dated 24th July, 2014 issued by the MoH&FW (PMSSY Division), now the MoH&FW instructed to release payment to M/s-HLL towards procurement of equipment which are more than the limit of Rs. two crore. The Secretary, MoHFW has informed that sanction from the Competent Authority for the expenditure sanction was taken at the Ministry level and respective AIIMS are to release the payment only. Accordingly, the GB has approved to release the payment to M/s-HLL and payment of the RA bills to M/s- HSCC at the AIIMS level after complying as required under the rules.

Further, the GB has noted the information as given regarding payment of the RA bills to the Contractors/HSCC and release of payment to M/S-HLL.

Relaxation of experiences by the SSC in respect of Dr. Saroj Kumar Das Majmudar for the post of Additional Professor:-

The Member-Secretary with the permission from Chair has presented that the Interview for the post of Additional Professor in the Department of Radio-therapy

was conducted by the Standing Selection Committee (SSC) on 15.10.15 and only one candidate namely Dr. Saroj Kumar Das Majumdar had appeared for the Interview. The SSC has recommended the name of the Dr. Majumdar for the post of Additional Professor in the Department of Radio Therapy, by relaxing five months of teaching/research experiences by terming him exceptional and also taking into consideration his teaching & research experiences in abroad. It has been found that he is having shortage of nine months of requisite teaching/research experiences at the time of processing for issue of offer of appointment. Further, the Member-Secretary has also stated that the post of Additional Professor in Radiotherapy is required to be filled up immediately for strengthening the department in the interest of smooth patient care. Hence, the Member Secretary has sought approval of the GB to

approve the relaxation of nine months of the teaching experiences in case of Dr. Das Majumdar. But, the advertisement for this post was not having any such condition of relaxation of experiences in exceptional case. Therefore, GB did not agree with the proposal as relaxation of experiences is not legally tenable if the same condition was not there in the advertisement. However, the GB has authorized the Director to re-advertise this post along with other post as felt necessary by him immediately to give him another opportunity to Dr. Saroj Das Majmudar along with others. The condition of the grant of relaxation of experiences in exceptional cases should clearly be inserted in future advertisement.
