Consequent upon the implementation of the 7<sup>th</sup> Pay Commision for Central Government employees, the proposal of the Ministry of Health and Family Welfare regarding extension of benefits of 7<sup>th</sup> CPC in respect of six new AIIMS located at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh has been considered in the Ministry of Finance, Department of Expenditure.

- 2. Approval of the Government is hereby conveyed for revision of pay and allowances of Non–Faculty members in accordance with Ministry of Finance OM No. 1/1/2016-E.III (A) dated 13.01.2017 & 26.07.2017. Only normal replacement pay scales as per Part A of the Schedule of CCS (RP) Rules, 2016 may be given to Non-Faculty of the six new Institutes. The decision on such of the existing allowances at present admissible to Non Faculty of the six new AIIMS as are exactly as per Central Government pattern will also be in accordance with Department of Expenditure OM No. 1/1/2016-E-III (A) dated 26<sup>th</sup> July, 2017, effective from 1<sup>st</sup> July 2017.

Consequent upon the implementation of the 7<sup>th</sup> Pay Commision for Central Government employees, the proposal of the Ministry of Health and Family Welfare regarding extension of benefits of 7<sup>th</sup> CPC in respect of six new AIIMS located at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh has been considered in the Ministry of Finance, Department of Expenditure.

- 2. In so far as revision of pay scales in case of Faculty posts is concerned, it was clarified by Ministry of Health& FW to Ministry of Finance that the existing pay scales of Faculty as specified by Ministry of Health as per their OM dated 31.12.2009 and 12.01.2010 were adopted on the basis of the pay scales allowed by the Ministry of HRD in respect of Faculty of Centrally Funded Technical Institutions (CFTIS), namely, IIM, IIT etc. as contained in their letter dated 18.08.2009.
