Subject: Appointment of AIIMS, Jodhpur as Mentor Institute for AIIMS Gorakhpur-reg.

Sir,

I am directed to convey the approval of Competent Authority for appointing All India Institute of Medical Sciences, Jodhpur, Rajasthan as Mentor Institute for the new upcoming AIIMS at Gorakhpur, Uttar Pradesh.

2. The Mentor Institute would handhold, support and guide the Mentee institute in the process of getting established. As the mentee institute will not have full administrative structure, the mentor institute will also support the mentee institutes in its routine administrative and financial functioning's, getting necessary approvals, funding and clearances till such time a regular administrative structure is put in place in the Mentee Institutes. Some of the issues which would require focus in the initial stages are as under:

- (a) Director, DDA and FA of the mentor institute would also be holding the corresponding charges of the mentee AIIMS till appointment of regular incumbents, against the substantive posts to be created and filled in the mentee institutions.
- (b) OPD Operationalization and MBBS batch for the first year of AIIMS, Gorakhpur is likely to start very soon. For this, Faculty and Non Faculty staff are to be appointed, for which a Mentoring Institute would support in the process.
- (c) Operationalization of OPD services and Undergraduate Courses etc at AIIMS Gorakhpur would require necessary flow of funds and resources. Funds would be released to the Mentor Institutes which have regular DDA and FA till such time a regular administrative and Financial structure is in place in the new Institutes.
 - All the fund requirement for early operationalization of the Mentee Institute would be released with the concurrence of FA and approval of Director of the Mentor Institute.
- (d) Various statutory approvals like approval of design of Radiotherapy bunkers etc. from Atomic Energy Regulatory Board (AERB), etc. are required during the process of establishment of AIIMS, which can be obtained by the staff of AIIMS only. The mentoring AIIMS needs to support the new AIIMS for seeking such approvals till a regular mechanism is put in place in the new AIIMS to obtain such approvals.

- 3. It is also mentioned here that the new AIIMS Gorakhpur is proposed to be funded through Extra Budgetary Resources. The Mentor AIIMS will enter into agreement with the Lending organization, initially as per requirement. A Loan Form in this respect for funding from Higher Education Financing Agency (HEFA) is also enclosed for taking up necessary action in filling up necessary documents for processing of Loan. However, in due course, responsibility with the asset and liabilities will be transferred to new AIIMS as and when the necessary administrative structures are in place in the new AIIMS.

4. The Mentor Institute would take up any other duties/ responsibilities in the mentoring role as may be required for operationalization of the AIIMS Gorakhpur.
