Subject: Filling up the various Project Cell posts at the new AIIMS-reg.

Madam/Sir,

I am directed to refer to this Ministry's letter of even No. dated 28th September, 2018 regarding transfer of project cell posts except Deputy Director (Admn.) in the new AIIMS.

2. As you may be aware that while the above decision for transfer of project cell posts to respective AIIMS was under consideration, PMSSY Division (MoHFW) advertised various project cell posts viz. Financial Advisor, Deputy Director (Administration), Superintending Engineer, Executive Engineer (Civil), Executive Engineer (Electrical) and Administrative Officer vide Advertisement dated 1st September in Employment News (copy enclosed). Last date for receiving application was 15th October, 2018. Among the applications received for six new AIIMS and other three new AIIMS, many candidates have applied for multiple AIIMS.

3. As the project cell posts have now been transferred to the respective AIIMS, with the approval of competent authority, a Committee of Directors is hereby constituted for completing the recruitment process (viz. interview, selection etc.) of above project cell posts of above new AIIMS except Deputy Director (Admn.), AIIMS Kalyani. The composition of the Committee of Directors is as under:

1. Director, AIIMS Raipur
2. Director, AIIMS Bhubaneswar
3. Director, AIIMS Nagpur
4. Director, AIIMS Kalyani

As regards the post of FA, the FA of AIIMS New Delhi will be member of the

committee. Similarly, for technical posts viz. SE & EE, Chief Engineer as nominated by CPWD will be member of the above Committee.

4. The Committee may conduct interview at any AIIMS suitably. To assist the Committee, AIIMS, Raipur may handle the recruitment process involving scrutiny of applications, issue of call letters etc. The recommendations of the Selection Committee may be placed before Hon'ble HFM for consideration/approval. From next time onwards, the recruitment for the above categories may be handled by the respective AIIMS/Mentor Institutes.

5. Director, AIIMS Raipur is requested to depute an official to this Division for collecting the applications of the above mentioned posts for further necessary action.

6. This issues with the approval of Hon'ble Minister of Health & Family Welfare, GOI.
