

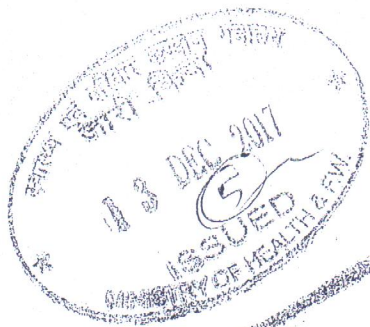

**Subject : Filling up the post of Financial Adviser in new AIIMS at Bhubaneswar, Jodhpur and Rishikesh on deputation basis.**

The undersigned is directed to say that this Ministry has established new AIIMS at Bhopal (MP), Bhubaneswar (Odisha), Jodhpur (Rajasthan), Patna (Bihar), Raipur (Chattisgarh) and Rishikesh (Uttarakhand) under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY).

2. The post of Financial Advisers at AIIMS Bhubaneswar, Jodhpur and Rishikesh have fallen vacant /are due to fall vacant in near future. These posts are in the scale of Rs. 37400-67000 plus Grade Pay of Rs. 8700/- (Pre-revised). It is proposed to fill up these posts by taking officers from other Government departments, Autonomous bodies on deputation. Eligibility criteria is as under:-

**“Upper age limit:** The maximum age limit for appointment by deputation shall be not exceeding 56 years .

**Eligibility :-** (i) Officers in the Group ‘A’ of Organised Accounts Service who are empanelled for appointment as Director in the Central Government Ministries/Department OR (ii) Officers in other Group ‘A’ Central Service who are empanelled for appointment as Director in the Central Government and who have working experience of at least three years in the field of Finance and Accounts OR (iii) Officers serving in the State Government’s Finance Service drawing a Grade Pay of Rs. 8700/- and above are eligible. Failing (i), (ii) and (iii)



above, officers of Organised Accounts Service holding the post of Deputy Secretary or equivalent on regular basis, in the pay band of Rs. 15600-39100+GP of Rs. 7600/- OR other Officers with 5 years regular service at the level of Deputy Secretary in the grade pay of 7600/- having three years experience in the field of Finance and Accounts can be considered".

3. This Ministry is in process of notifying the advertisement in newspapers and in Employment News shortly for the posts of F.A., AIIMS Bhubaneswar, Jodhpur and Rishikesh.
