Sub: Constitution of a Committee based on the observations of the Committee on Subordinate Legislation, Rajya Sabha.

1. During the course of oral evidence on the implementation of 178th and 212th Reports of the Committee on Subordinate Legislation, Rajya Sabha, on the 28th of February 2014 by Secretary, Department of Health & Family Welfare before the Committee, it had been stated that the nature of formulation of Rules and Regulations had been changed due to the fact that there were new AIIMS being set up at Bhopal, Bhubaneswar, Jodhpur, Patna, Rae Bareli, Raipur and Rishikesh and there was a need for conformity. In addition to this context and other issues facing the Institutes set up under the AIIMS Act 1956 (including the amendment done in 2012), and, with the approval of the Health & Family Welfare Minister (President of different AIIMS) the following Committee is hereby constituted to look at the entire aspect of the issues involved/ raised in the above mentioned two reports of the Committee on Subordinate Legislation in a holistic manner and submit its report to the Government:

- 2. Terms of Reference of the above constituted Committee are as under:
 - To consider the observations of the Committee on Subordinate Legislation, Rajya Sabha in their reports and proceedings on AIIMS, New Delhi.

To consider the replies of the Ministry filed before the Committee on Subordinate Legislation, Rajya Sabha in their proceedings on AIIMS New Delhi.

- To consider other reports and recommendations on AIIMS New Delhi and on other AIIMS.
- To recommend draft AIIMS Rules and draft AIIMS Regulations under the AIIMS Act.
- 3. The Committee may requisition or to engage any other expert or agency depending upon need to carry out tasks mentioned in paragraph 2.a, 2.b, 2.c and 2.d above. TA/DA, accommodation, secretarial assistance and sitting fee to nonofficial Chairperson and non-official Members shall be paid by AIIMS New Delhi from out of its budget as per its norms and entitlements. All expenses on the functioning and proceedings of the Committee shall be met by AIIMS New Delhi to start with, and equally shared by all AIIMS including six new AIIMS from out of Grant-in-Aid provided by the Ministry.
- The Committee will submit its report within six months from the date of issue of this order.
