Sub : Constitution of Committee on procurement of common and/or specialized equipments for six New AIIMS under PMSSY.

With the approval of Competent Authority and in supersession of all previous orders on the subject, it has been decided to constitute a Committee on Procurement of common and/or specialised equipments etc. for six new AIIMS at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur, Rishikesh with the following composition:

vi)	Joint Secretary (PMSSY), MoHFW-	Member Secretary

2. The terms of reference of the Committee are:

- i. To review and decide the requirements and to devise specifications for common and / or specialized equipments such as Modular OTs, intelligent OTs, medical Gas pipeline system, manifold, kitchen/laundry/CSSD equipments etc.
- ii. To ensure quick procurement of the equipments through open tender basis.
- iii. To ensure quality and timely delivery in procurement process.
- iv. To supervise and monitor supply, installation, testing, commissioning etc. of equipments such as Modular OTs, intelligent OTs, medical gas pipeline system, manifold, kitchen/ laundry/ CSSD equipments etc.

3. The Committee may take assistance of such other specialists or organizations as may be required in the process of procurement.
